But Saudi Arabia's experience also shows the limits of policies that exclude the unvaccinated from offices, schools and most public places; even in an absolute monarchy that criminalises dissent, implementation

"The government is forcing it on citizens — this is complete slavery," said 23-year-old Rawan, an unemployed



law graduate who took one dose but doesn't want a second because she's worried about long-term side effects. Like other Saudis opposed to the rules, she asked Bloomberg to withhold her last name because of the risks of criticising the state.

The ministry of health and the government's Center for International Communication didn't respond to requests for comment. Officials have repeatedly stressed the safety and efficacy of the vaccines and said the requirements help protect the public.

Mandatory vaccination has become a heated topic around the world as Covid-19 cases surge anew, sparking legal debates and protests as employers and governments tighten requirements. France has instituted a vaccine pass that's now required to access a slew of public venues, while New York City has introduced mandatory immunization for teachers and civil servants and anyone eating indoors at a restaurant or visiting a gym or entertainment venue. Indonesia has threatened to impose fines on those resisting vaccination.

Islamic State 'Beatle' to plead guilty to US terrorism charges

A BRITISH-BORN MAN who was a member of a team of Islamic State militants in Syria nicknamed "The Beatles" accused of beheading American hostages was due to plead guilty on Thursday to US criminal charges, according to a federal court record.

A docket entry for the US District Court in Alexandria, Virginia, showed a change of plea hearing was scheduled on Thursday for Alexanda Kotey, one of two Islamic State members who had been held in Iraq by the US military before being flown to the United States to face trial on terrorism charges.

Shafee Elsheikh, a Sudanese-born British resident extradited to the United States with Kotey, face charges that include hostage-taking resulting in death and conspiracy to provide material support to terrorists. Kotey and Elsheikh were citizens of the United Kingdom, but the British government withdrew their citizenship. They are alleged to have belonged to a four-member Islamic State cell nicknamed "The Beatles" because of their **—REUTERS** British accents.
